



Abbreviations and Definitions

Road building, like every other occupation, has its own vocabulary, its "shorthand" and its abbreviations. The following are those most commonly used in this booklet:

Armor Coat - A thin covering of gravel placed after the roadway surface has been sprayed with asphalt.

Br. (Bridge) - Structure over stream or roadway. May include new construction, reconstruction, widening or rehabilitation of existing structure. May include reconstruction of approaches.

Chip Seal - A thin layer of crushed aggregate after the roadway has been sprayed with asphalt.

Conc. (Concrete)

Crack Seal - The sealing of cracks in concrete and asphalt pavements with a hot-pour type sealer.

Culv. (Culverts) - Pipes or concrete boxes necessary to carry water under the roadway.

Gr. (Grading) - The movement of earth needed to construct the project as designed.

Grinding - Diamond grinding to smooth the surface of a concrete pavement.

Intersection - Construction of a new intersection or revision of existing intersection and connecting roads.

Joint Seal - The replacement of the seal at the transverse and longitudinal joints in concrete pavements with a hot-pour type sealer.

Microsurfacing - A thin layer of asphalt slurry material spread to remove rutting and surface irregularities in asphalt pavements.

Pvmt. (Pavement)

Resurf. (Resurfacing) - Additional layer of surfacing material placed on top of existing hard-surfaced road to improve rideability and strength of roadway. May include minor widening of roadway and structures.

S. Shld. (Surfaced Shoulders) - Hard surfacing the shoulders of an existing or new hard-surfaced road.

Str. (Structures) - Culverts, bridges and/or viaducts, either new or reconstructed.

Surf. (Surfacing) - Hard surfacing, either concrete or asphalt.

Underpass - Structure on roadway passing under railroad tracks.

Urban - Construction of divided or undivided curbed roadway in an urban area. May include grading, structure and incidental work.

Viaduct - Structure over a railroad or other roadway.

Funding Sources

Nebraska's Surface Transportation Program is financed by two major funding sources – state and federal funds.

State Funds

Highway Trust Fund – Nebraska is a “pay-as-you-go” state using the traditional revenue sources to fund the needs of the State Highway System. State funds are derived from three primary highway user revenue sources: (1) fuel taxes 60%, (2) sales taxes on new and used motor vehicles and trailers 30%, and (3) motor vehicle registration fees 10%. Approximately 60% is designated to the Department of Roads, and 40% to the cities and counties of Nebraska.

The FY-2016 State Highway System program is based on projected total state highway trust fund revenues of \$412.5 million. This program was originally estimated at \$400 million. LB657, which was signed into law on May 20, 2015, increased the state funding by an additional \$10 million. LB610A, which was signed into law on May 14, 2015, increases the motor fuel tax by 1½ cents effective January 1, 2016, which is estimated to generate an additional \$2.5 million in revenue for the state highway system and additional \$4 million for the local roadway system.

Approximately \$232 million of the state highway trust fund revenue is set aside for routine highway maintenance, administration, capital facilities, supportive services, carrier enforcement, transit, rail, construction overhead, and the Federal Fund Purchase program. This expenditure level was reduced by \$10.5 million through FY-16 legislative appropriation action. The remaining revenue is available for the state highway construction program.

Build Nebraska Act – One quarter of one percent of general fund sales tax revenue is designated for Nebraska roadways. Eighty-five percent is for the state surface transportation projects, estimated at approximately \$63 million. Fifteen percent is for local roads and streets, estimated at approximately \$11 million.


Additionally, about \$8.2 million of Recreation Road, Grade Crossing, and State-aid Bridge funds are available for projects both on and off the State Highway System.

Federal Funds


Federal funds are derived from user revenues paid into the Federal Highway Trust Fund, 90% from federal motor fuel taxes and 10% from heavy vehicle sales and use fees and heavy tire taxes. Funding is provided to the states through an annual appropriation process which is distributed by means of formula allocations as defined by law.

The transportation act, referred to as MAP-21, expired at the end of FY-2014, on September 30, 2014. Congress has not yet passed a new transportation act or an annual appropriation for FY-2015 or FY-2016. Consequently, the FY-16 Surface Transportation Program is based on the best funding assumption available at this time.

Federal-aid highway funding made available to Nebraska is shared between the state, cities, and counties. The Department of Roads purchases the federal funding authority for cities, counties and bridges from locals with 80 cents for each dollar.

Fiscal Year 2016 Program Financing


State Highway System


Local System

The local system will include those projects selected by the local public agencies for FY-2016 as determined through the local planning and programming process.

The local system program is financed from the State Highway Trust Fund (including revenue received from the Federal Fund Purchase Program), Federal Highway Funds, and the Build Nebraska Act. Funding is also available from the State Recreation Road and the State Aid Bridge Fund.






District One


