Chair Hohenstein called for discussion on the LEC agreement. It was suggested to form a committee between the City LEC and the County to start reviewing and amending the current contract in about 60 days (October/November). Commissioner Launsby questioned if notification isn't sent, then operate another year under same contract. Commissioner Love suggested Sheriff also be included in the discussions. Commissioner Giese asked County Attorney, Kim Watson, if it was okay to not send a letter notifying the City of our intentions to negotiate was okay. After further discussion regarding some of the specifics such as space and what the county is responsible to pay partial wages for, County Attorney, Kim Watson, did advise that case law states we can renegotiate the current agreement without the need to terminate. Lue Franco, So Sioux City, questioned the terms of the agreement and felt the county should send a letter due to the termination clause. She questioned whether there was a conflict of interest for the Board Members - Chair Hohenstein informed he had checked with attorneys, and they told him there was no conflict. Commissioner Love moved, seconded by Commissioner Hohenstein to not send a letter to the Law Enforcement Center terminating the current contract as it has been agreed that each party is willing to renegotiate the current contract before budgets are due next year. ROLL CALL VOTE: Van Berkum-Yes. Giese-No, Launsby-No, Hohenstein-Yes, Love-Yes. MOTION CARRIED.

Commissioner Love moved, seconded by Commissioner Van Berkum to approve the Chair to sign the NIRMA Agreement and Release on the insurance claim occurring on November 7, 2023 involving the deputy vehicle that was totaled due to a fire. ROLL CALL VOTE: Giese-Yes, Launsby-Yes, Hohenstein-Yes, Love-Yes, Van Berkum-Yes. UNANIMOUS MOTION CARRIED.

Chair Hohenstein informed he would be appointing a committee to review applicants for the upcoming vacancy of County Treasurer. Commissioner Love stated he felt it would be appropriate to have Commissioners Hohenstein and Van Berkum on the committee as the other commissioners will term out in January. Lue Franco, So Sioux City, passed out a printout of statute 32-563 Vacancies; pending appointment or election; possession and control of office; persons authorized; and she expressed her interpretation as she felt no committee was necessary and that the deputy should be appointed. There was further discussion regarding previous vacancies. Chair Hohenstein informed that NIRMA recommended this process be followed. Chair Hohenstein appointed Commissioner Van Berkum, himself and Chief Deputy County Attorney, Deb Fergen to be on the committee to appoint a County Treasurer; the position will be advertised for two weeks and hope to have someone appointed by October 11, 2024.

Jolene Gubbels, Highway Superintendent, presented an agreement from Midwest Engineering Inc. for construction services on the grading of S Avenue North of Nebrasja Highway 35 requesting Board approval. This project requires the help of engineers to get the project done correctly. Commissioner Love moved, seconded by Commissioner Giese to approve the Midwest Engineering Inc. agreement for construction engineering services for the grading on S Avenue North of NE Highway 35 project #24053. ROLL CALL VOTE:, Launsby-Yes, Hohenstein-Yes, Love-Yes, Van Berkum-Yes, Giese-Yes. UNANIMOUS MOTION CARRIED.

Jeff Dooley and Brett Langley, CEC, presented the Advertisement for Bid for the Likuwanta Drive Improvement project and requested Board approval to proceed with bid letting with bids being received until Tuesday, September 10<sup>th</sup> at 1:30 pm. They reported that Crary Huff Law Firm is working on the easements and 8 lots have been sold and homes started. Commissioner Love moved, seconded by Commissioner Van Berkum to approve the Advertisement for Bids for the Likuwanta Drive Improvement project with bid opening on Tuesday, September 10<sup>th</sup> at 1:30 pm. ROLL CALL VOTE: Hohenstein-Yes, Love-Yes, Van Berkum-Yes, Giese-Yes, Launsby-No. UNANIMOUS MOTION CARRIED.

Jolene Gubbels, Highway Superintendent, presented the Road Report for August 4 to August 17, 2024. Total Road Maintenance – 195.5 hours, Overtime – 9 hours, Tree/Debris removal – 35.5 hours; Culverts – 73.5 hours (197<sup>th</sup>, 225<sup>th</sup> and Moody), Mowing – 2 hours, Gravel hauling – 117 hours, 865.67 tons hauled, Sign repair – 12.5 hours. Road concerns: Grading – 225<sup>th</sup>, S Bluff, Perry Ave, O Ave, 250<sup>th</sup>, Golf Rd, H Ave and Fiddler Creek, Gravel-152<sup>nd</sup> and 207th and Culverts-Moody Rd and Fiddler Creek. Ms. Gubbels informed that the department was in training this week sponsored by NIRMA. Norfolk Contracting has been contacted regarding the rough approaches on Dorcey bridge and will be out to look at it and make repairs.

ARPA – Jolene Gubbels, Highway Superintendent, presented a request for purchase a semi-load of motor grader blades vs partial loads and the savings. Commissioner Giese moved, seconded by Commissioner Launsby to approve the request to purchase a semi-load of motor grader blades from Ziegler Cat for \$28,110.40 using ARPA funds. ROLL CALL VOTE: Love-Yes, Van Berkum-Yes, Giese-Yes, Launsby-Yes, Hohenstein-Yes. UNANIMOUS MOTION CARRIED.

Commissioner Launsby requested Jolene Gubbels, Highway Superintendent, evaluate the road/ditches most in need of repair. Ms. Gubbels presented a proposal from Midwest Engineering, Inc. for engineering the road maintenance bidding for M Avenue, Hubbard to 270<sup>th</sup> and 260<sup>th</sup> and M Avenue to NE Highway 35, approximately 12.5 miles at a cost of not more than \$54,250. This process will help the road department know where dirt needs to be moved, culverts put in and long-term road conditions. Commissioner Love moved, seconded by Commissioner Launsby to approve the Midwest Engineering, Inc. 2024 Road Maintenance engineering and bidding agreement for M Avenue, Hubbard to 270<sup>th</sup> and 260<sup>th</sup> and M Avenue to NE Highway 35, approximately 12.5 miles at a cost of not more than \$54,250.
