## SIGNING OF THE YEAR-END CERTIFICATION OF COUNTY HIGHWAY SUPERINTENDENT 2024

Resolution No. 24C-029 Whereas: State of Nebraska Statutes, sections 39-2302, and 39-2501 through 39-2505 detail the requirements that must be met in order for a county to qualify for an annual Incentive Payment; and Whereas: The State of Nebraska Department of Transportation (NDOT) requires that each county must annually certify (by December 31st of each year) the appointment(s) of the County Highway Superintendent(s) to the NDOT using the Year-End Certification of County Highway Superintendent form; and Whereas: The NDOT requires that such certification shall also include a copy of the documentation of the county highway superintendent's appointment, i.e., meeting minutes showing the appointment of the County Highway Superintendent by their name as it appears on their License (if applicable), their License Number (if applicable) and Class of License (if applicable), the type of appointment, i.e., employed or under contract (consultant, or interlocal agreement with another county and/or incorporated municipality), and the beginning date of the appointment; and Whereas: The NDOT also requires that such Year-End Certification of County Highway Superintendent form shall be signed by the County Board Chairperson and shall include a copy of a resolution of the County Board authorizing the signing of the Year-End Certification of County Highway Superintendent form by the County Board Chairperson. Be it resolved that the County Board Chairperson of \_\_\_\_\_\_ Dakota is hereby authorized to sign the attached Year-End Certification of County Highway Superintendent form(s). Adopted this 12th day of November, 2024 at Dakota City, Nebraska. County Board Members

Brett Langley, CEC, explained to the Board that the issue at 647 Likuwanta Drive with the septic was holding up the ditch work progress. As discussed before this septic line goes under the road, is in the County ROW, and is shallow. The options would be to install a grinder, sump pit, pump, pressure line, and splitter box either on the owners property or the property across the street that he has easement on. It would be best if this septic was relocated to the property owner's property, if code allows it. Mr. Langley suggested someone design a plan to research this, the permitting, and to relocate it. The contractor will then price a change order, which would need to be approved. Commissioner Love moved, seconded by Commissioner Hohenstein to have CEC move forward with a design plan to relocate the septic at 647 Likuwanta Drive so that this project can be bid and a change order to the project come back before the Board for approval. ROLL CALL VOTE: Launsby-Yes, Hohenstein-Yes, Love-Yes, Van Berkum-Yes, Giese-Yes. UNANIMOUS MOTION CARRIED.

Brett Langley, CEC, explained to the Board that there are 2 property owners who had rock along the road frontage before that they used for parking. The project plan only has the paving of the road and the driveways of the property owners and to seed the edges/ditches. Mr. Langley offered up options on removing all rock (1) per the current plan, putting a smaller portion back(2) as a compromise, or putting all of the rock back to match how it was before the project (3). He suggested option 1 or 2 in his opinion. Currently the County does not allow parking in the County ROW as it becomes a liability. The Commissioners agreed to continue with the already agreed upon engineered plans and took no new action.

Jolene Gubbels, Highway Superintendent, presented the Road Report for October 27, 2024 to November 9, 2024. Total road maintenance-169 hours; Tree/Debris removal-11 hours; Culverts/Rd projects-75 hours 250<sup>th</sup> and 24 hours 110th; Gravel Hauling-106.25 hours; total tons hauled-874.89; sign repair/barricading-18 hours. Grading concerns- Fiddler Creek and L Ave, Gravel on Fiddler Creek and Jewel Ave. M Avenue bids will be brought to the Board and awarded at the 11-25-24 meeting. The S Avenue road project will be rocked and opened soon.
