Commissioner Hohenstein moved, seconded by Commissioner Van Berkum to approve the Midwest Alarm Services agreement to monitor the fire alarm system in the courthouse. ROLL CALL VOTE: Giese-Yes, Launsby-Yes, Hohenstein-Yes, Van Berkum-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

Commissioner Hohenstein moved, seconded by Commissioner Van Berkum to approve the Schumacher Elevator Company Maintenance Agreement for the courthouse elevator. ROLL CALL VOTE: Launsby-Yes, Hohenstein-Yes, Van Berkum-Yes, Giese-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

Todd Uhl, Jail Maintenance and Jack Carlson, Albireo Energy, explained that when working on installing the upgraded smoke evacuation system and found that there are several relays and actuators that need replaced. These components are located on the ceiling that is not accessible by the jails lift so one will need to be rented. The proposed quote will move these components to an area that is easily accessible and fully functional. Commissioner Hohenstein moved, seconded by Commissioner Giese to approve the Albireo Energy change order quote for all scopes of work to repair the smoke evacuation system in the Dakota County Jail for \$19,762.00 using ARPA funds. ROLL CALL VOTE: Hohenstein-Yes, Van Berkum-Yes, Giese-Yes, Launsby-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

Todd Uhl, Jail Maintenance, informed the Board that the Jail HVAC systems are experiencing some issues. One of the units is down. He had the power company check into power surges and there were none reported over the threshold. He has obtained 3 quotes and will bring them to the next meeting for approval.

Jolene Gubbels, Highway Superintendent, presented the Road Report for November 10, 2024 to November 23, 2024. Total road maintenance-151.5 hours; Culvers/Rd projects-7 hours 260<sup>th</sup> & M Ave; Gravel hauling-140 hours; total tons hauled-442.52 into yard and 1413.71 hauled; Sign repair/barricading-9 hours and weed spraying-1 hour. Gravel-192<sup>nd</sup> St, O Ave, S Ave and T Ave. Not in favor of closing F Avenue.

Commissioner Launsby noted that he believes the issues with Olson Farm invoices have been resolved. After further discussion regarding property lines and salt brine runoff, this item will come back to the Board at the next meeting.

Discuss and approve or deny projects or purchases with monies from the American Rescue Plan Act (ARPA) relief funding. Remaining ARPA funds is \$492,353.97.

Commissioner Hohenstein moved, seconded by Commissioner Giese to approve the Accounts Payable Claim to Dakota County Star for M Avenue Bidders Legal Notice for \$79.21 using ARPA Funds. ROLL CALL VOTE: Van Berkum-Yes, Giese-Yes, Launsby-Yes, Hohenstein-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

Commissioner Giese moved, seconded by Commissioner Launsby to approve the quote and purchase of solid fire rated door for the DMV for safety reasons from Builders First Source \$1207.25 using ARPA funds. ROLL CALL VOTE: Giese-Yes, Launsby-Yes, Hohenstein-Yes, Van Berkum-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

The bids for the M Avenue road projects - 4 sections came in at: Cooney Fertilizer Inc. \$163,608.98, Oban Construction Inc. \$244,142.10, and Steve Harris Construction Inc. \$289,559.50. The County will provide the culverts and do the seeding and gravel to help keep costs down. Some discussion on type of rock to purchase and the number of culverts was discussed along with pricing. M Avenue is one of the busiest roads in Dakota County, a lot of truck traffic. The width of the road will be 28 feet – some areas are as wide at 40 feet. County working within ROW and engineered at road standards. Jolene also mentioned that Norfolk Contracting will begin work this week on the repairs for Dorcey bridge and shut down for a couple of weeks.

Commissioner Giese moved, seconded by Commissioner Hohenstein to award the bid for the M Avenue – 4 section road projects to Cooney Fertilizer Inc. for \$163,608.98 using ARPA funds. ROLL CALL VOTE: Launsby-Yes, Hohenstein-Yes, Van Berkum-Yes, Giese-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

The Commissioners asked that quotes for more culverts and different gravel types be brought back before the Board for review and approval.

Commissioner Hohenstein moved, seconded by Commissioner Launsby to approve purchasing grass seed from Home Depot and grass blankets from DSG using ARPA funds for road projects. ROLL CALL VOTE: Hohenstein-Yes, Van Berkum-Yes, Giese-Yes, Launsby-Yes, Love-Absent. UNANIMOUS MOTION CARRIED.

Commissioner Committee Reports: Commissioner Giese informed that he talked with the State regarding the M Avenue paving and was informed that since M Avenue is a county road, they will not help with that. Commissioner Giese suggested that the next Board consider possibly building into the budget for an employee appreciation recognition since the pop fund has gone away. Commissioner Launsby attended a NorthStar meeting and P&Z meeting and informed that the solar farm project is getting close to having public hearings.
