Commissioner Bousquet will work on getting quotes and bring this issue back to the Board.

Chair Hohenstein announced that the employee that was out on FMLA leave has been released back to work with no restrictions.

Jolene Gubbels, Highway Superintendent, asked the Board if they wanted Josh with MEI to move forward with getting change order quotes to have M Avenue Road at 30 feet vs 28 feet. The Board wished to move forward with getting the change order quotes. Ms. Gubbels asked the Board if they would be interested in getting quotes to have Cooney Fertilizer Inc. disk, roll and pack the concrete base before putting gravel on top to help with stabilization of the road. The Board agreed and requested estimates.

Jolene Gubbels, Highway Superintendent, presented the Bi-weekly Road Report for February 2 to February 15, 2025. Total Road Maintenance - 52 hours; Overtime hours – 42.5 hours; culverts/RD projects – 16 hours S Bluff; snow removal – 165 hours. Road concerns: Grading – L Ave, Nodaway Rd, Elgin Ave. Gravel Bids and Bridge Inspection Bids will be opened on February 27th and presented at the March 3rd meeting. Chair Hohenstein informed that interviews for the Road Foreman will take place next week and brought before the Board on March 3rd. Road Operator and Weed/Sign interviews will take place after the Road Foreman is appointed.

Commissioner Committee Reports: Commissioner Reed reported that he attended the Emergency Manager training/exercise session and learned a lot. He believes the County should work on a mutual aid agreement with Emergency Managers from Union County, SD and Woodbury County, IA. Commissioner Hohenstein reported that he attended the Board Chair workshop in Kearney and the new budget reforms are going to make it hard for counties to budget. Commissioner Rodriguez reported he attended the Health Board meeting, and the department will be helping the fire departments obtain PPE with the grant they recently received.

Mail and/or Emergency Business: Commissioner Hohenstein read a letter he received from a local veteran regarding the stellar work of Nick Nieman and how thankful he was.

Commissioner Van Berkum moved, seconded by Commissioner Reed, to adjourn the meeting. All in favor. Chair Hohenstein adjourned the Board of Commissioners meeting of February 18, 2025, at 3:32 p.m.
