Commissioner Reed informed the public that this hearing was for the Solar Overlay District which means this is put in place to protect landowners adjacent to projects.

Support: Ethan Frazier, Mission Clean Energy, explained that this is a solar and battery storage project for renewable energy. He explained that there is a demand across the country for energy and it ties into existing power supplies. He commented on the Planning and Zoning Commission and Board have worked on putting together ordinances and regulations, setbacks from homes, and the benefits to the County and the Homer school district.

Aubrey Copeland, Mission Clean Energy, explained that Mission Clean Energy started in 2022 and it takes approximately 5 years to get a solar farm running and they do not currently have any.

Opposition: Several residents spoke in opposition to the solar farm. Summary (spelling of names could be incorrect) Don Kubik-damaging roads; Tony Staab-prime farmland and snow drifting; Ron Reynor-snow drifts, power sold to who, health effects, taxes, who removes them, sustainability, heat issues; Lou Franco-values, taxes, livestock, water runoff, downfalls; Dennis McManigal-looking at solar farm from front window, waste of good farm ground. Commissioner Rodriguez and Hohenstein commented that change is inevitable. The City of So Sioux City is looking to expand and develop industries outside of city limits.

Neutral: None.

Chair Hohenstein closed the public hearing at 7:29 p.m.

Commissioner Reed moved, seconded by Commissioner Rodriguez to approve the Conditional Use Permit from Sternwheeler Solar Project, LLC at the property located at Section 10-11, 14-16, 21-23, 25, 26-28, Township 28N, Range 8E on approximately 2,900 acres for the Solar Overlay District noting the Dakota County Planning Commission recommended approval. ROLL CALL VOTE: Van Berkum-Yes, Bousquet-Yes, Reed-Yes, Hohenstein-Yes, Rodriguez-Yes. UNANIMOUS MOTION CARRIED.

Chair Hohenstein opened the Public Hearing for the purpose of giving citizens the opportunity to offer support, opposition or make neutral comment regarding a request for approval of Conditional Use Permits from Sternwheeler Solar Project, LLC at the property located at Section 10-11, 14-16, 21-23, 25, 26-28, Township 28N, Range 8E on approximately 2,461 acres for the purposed construction and operation of the Sternwheeler Solar Project comprising a solar photovoltaic and battery energy storage system at 7:30 p.m.

Chair Hohenstein read to the public the following for their information:

The Board has the authority to create regulations regarding the installation of solar panels on private property (as long as those regulations are part of a comprehensive zoning or development plan) under Nebraska Revised Statute section 66-913. Counties with zoning jurisdiction are authorized to include provisions for encouraging solar energy use and protecting access to solar energy in their zoning regulations. They can regulate things like height, location, and setback of structures.

The Board can adopt zoning resolutions that regulate land use to promote public health, safety, and welfare. The Board may grant conditional use permits for specific uses of property, including solar panel installation, if those uses are identified in the county zoning regulations. The Board must adopt standards and procedures for granting these permits in a way that promotes the public interest and ensures equitable treatment.

The Board is trying to protect the public by adopting appropriate regulations for solar energy as best they can while at the same time protecting surrounding property from interference with their own property rights. The Board must balance encouraging the use of solar energy systems with protecting the public interest.

Opposition: Several residents spoke in opposition to the solar farm. Summary (spelling of names could be incorrect) Sally Reinert-P&Z implemented in 1970's and the Board could do away with if they choose, referenced P&Z reg 600.3 necessary conditions; Lou Franco-people enjoy property they own, will affect wildlife, environment, chemical concerns; Don Kubik-Pierce County has problems with roads, county taxpayers money, Dakota County has gumbo.

Audrey Copeland, Mission Clean Energy, explained that the company will have in place road use agreements and maintenance agreements prior to construction.

Kenny Baker-concerned about stormwater and flooding; Dennis Reinert-served on P&Z many years ago and failed to follow the regulations set and NIRMA had to step in, advised to be sure to follow the rules; Ron Renor-wants guarantee that taxes and values will not go up, dust control is an issue, snow drifting.

Ethan Frazier, Mission Clean Energy, advised that before project begins there will be agreements approved and signed regarding vegetative management, stormwater management, and fencing. Troy Launsby-selling point is income from taxes, wanted firm numbers on revenue.

David Levy, Attorney with Baird Holm, provided estimated revenue numbers and some of the splits, advised there are statutes and legislation that provide guidance, and numbers change based on levy and valuations.

Scott Davidson-opposed, wanted to know if there is a contract for energy, dust control a concern, suggested waiting a few months before making decisions.

Marcy Broyhill-wind & solar are 3rd world power sources – nuclear fusion and fission are being explored, wanted to know who the investors are.

Audrey Copeland, Mission Clean Energy, advised the investors can be found on the website. Mission Clean Energy is a US owned company, and some investors are global. Solar is the fastest and cheapest energy to buy. David Levy commented that NPPD buys energy.

Several more residents stood and opposed the project. Neutral: There were none.

Support:

Oscar Gomez, City of SSC Economic Development Director, spoke in favor of the project stating revenue is needed and there is a need for growth. He noted that if the permits and guidelines are not followed the project can be stopped.

Dustin Marvel-Omaha Public Power District, spoke in favor of the project stating Nebraska needs electrons now and solar and wind creates that. It will bring benefits to the schools and residents. Nebraska buys energy locally.

David Levy, Attorney with Baird Holm, commented on P&Z reg 600.3 does not give veto power. Reg 600.7-outilines the solar energy goals and balances the needs of the public. Requests the Boards approval of Mission Clean Energy conditional use permit and the findings of fact.

Audrey Copeland, Mission Clean Energy, mentioned again that there will be several agreements put into place prior to construction.

Chair Hohenstein closed the public hearing at 8:39 p.m.

Commissioner Reed moved, seconded by Commissioner Rodriguez to approve the Conditional Use Permit and Findings of Fact with conditions from Sternwheeler Solar Project, LLC at the property located at Section 10-11, 14-16, 21-23, 25, 26-28, Township 28N, Range 8E on approximately 2,461 acres for the purposed construction and operation of the Sternwheeler Solar Project comprising a solar photovoltaic and battery energy storage system noting the Dakota County Planning Commission recommends approval. ROLL CALL VOTE: Bousquet-No, Reed-Yes, Hohenstein-Yes, Rodriguez-Yes, Van Berkum-Yes. UNANIMOUS MOTION CARRIED.

Commissioner Committee Reports: Commissioner Reed attended the NACO Northeast Meeting. Commissioner Rodriguez wants to form a legislative committee.
