Julie Boyle with the Nebraska/Dakota County Extension office presented a quarterly report on what has been going on with their department.

Board discussed the elected official salary setting process. Commissioner Reed shared the various comparison information between Dakota County and other counties in Nebraska and commented that there is not one other county that compares to our demographics. Dakota County Elected Officials are underpaid compared to other counties. Due to budget constraints the Board must be responsible. With that the committee suggested the Elected Officials receive an 8.43% increase from the 2026 salary for 2027 and Commissioners receive a 4.6% increase from the 2026 salary for 2027 with 2.5% for 2028, 2029, 2030; increase the Chair extra pay from \$1200 to \$1400 per year; and add \$6500 per year for the Election Commissioner position. Commissioner Bousquet suggested the Commissioner pay remain the same. Commissioner Hohenstein moved, seconded by Commissioner Van Berkum to approve Elected Official Salary Resolution 25C-030 for 2027, 2028, 2029, 2030 pursuant to Neb Rev Stat 23-1114. ROLL CALL VOTE: Van Berkum-Yes, Bousquet-Yes, Reed-Yes, Hohenstein-Yes; Rodriguez-Yes. UNANIMOUS MOTION CARRIED.

RESOLUTION 25C-030 A RESOLUTION ESTABLISHING SALARIES FOR THE ELECTED OFFICIALS OF DAKOTA COUNTY NEBRASKA

WHEREAS, pursuant to Section 23-1114 of the Revised Statutes of the State of Nebraska, the Dakota County Board of Commissioners are required to determine and set the salaries of the various elected officials of the County prior to January 15th of the year in which a General Election will be held for the respective offices,

NOW, THEREFORE BE IT RESOLVED, by the County Board of Commissioners of Dakota County,

Nebraska, hereby fixes the salaries of the Dakota County Elected Officials as follows:

*Election Commissioner. The Dakota County Clerk will receive \$6,500 per year for serving as the Dakota County Election Commissioner in addition to the annual salary set for the Dakota County Clerk. Additional compensation will be paid from the Election Budget throughout the year bi-weekly on the regular pay schedule. If at any time the County Clerk is relieved of Election Commissioner duties, the additional compensation will be removed.

Chairman of the Board of County Commissioners. The annual salary for the Chairman of the Board of County Commissioners shall be an additional \$1,400.00 annually during the term of the office 2027, 2028, 2029 and 2030.

Benefits. In addition to the above salary, each Elected Official shall receive during his or her term of office a single health and dental insurance coverage policy and be a member of the same health and dental and medical group plan as offered to all county employees; and a \$15,000 life insurance policy. Elected officials shall be enrolled in and shall receive the benefits of the County Employee's Retirement System, to participate in such programs on the effective date of such programs as approved by the County Board. The county reserves the right to enter into any program for the benefit of employees of the county (including elected officials), such as insurance programs and such other programs as may be approved, with the right of elected officials granted to participate in such programs on the effective date of such programs as approved by the board. It is the intent of the Dakota County Board of Commissioners that participation in such programs shall not constitute an increase in the herein adopted salary but shall be and is part of such salary as adopted and approved by this resolution.

Cash in Lieu of Health Insurance. In addition to the above stated salary, a County Commissioner shall have the option to be a member of the same health and dental medical group plan as offered to all county employees, which is single coverage; or shall have the option at the discretion of each Commissioner to elect a stipend of \$400.00 per month in lieu of receiving medical coverage through the county medical plan. The election will remain in force for the remainder of the Commissioner's term, absent a qualifying event.

Resolution approved, passed, and adopted this 8th day of December, 2025.

Board discussed whether to approve or not approve adopting a 2026 salary resolution for deputies of elected officials. Chair Hohenstein explained that some years back a resolution setting deputy salaries was implemented and taken away from the Elected Officials. If the Board gives this back to the Elected Official it will be up to the Commissioners to set the budgets of the Elected Officials and it will be up to the Elected Officials to stay within their budgets. Commissioner Reed moved, seconded by Commissioner Rodriguez to not approve a resolution setting Deputy salaries and give the Elected Officials the responsibility of setting salaries of their deputies and maintain financial control over their set budgets without going over the spending authority. ROLL CALL VOTE: Bousquet-Yes, Reed-Yes, Hohenstein-Yes; Rodriguez-Yes, Van Berkum-Yes. UNANIMOUS MOTION CARRIED.

Commissioners discussed the need to change the speed limit on Dixon Path. Commissioner Van Berkum stated he had talked with several residents and they were in favor. Commissioner Bousquet suggested installing flashing speed signs. Commissioner Rodriguez commented that paying for studies and then going against their recommendations is not good. Commissioner Van Berkum moved, seconded by Commissioner Bousquet to approve Resolution 25C-031 changing speed limit on Dixon Path to 25 mph and resigning the road. ROLL CALL VOTE: Reed-Yes, Hohenstein-Yes; Rodriguez-Yes, Van Berkum-Yes, Bousquet-Yes. UNANIMOUS MOTION CARRIED.

Jolene Gubbels, Highway Superintendent, presented the Bi-weekly Road Report from November 23, 2025 to December 6, 2025. Total Road Maintenance – 19 hours; overtime hours: 103.25; tree/debris removal – 67 hours; asphalt patching – 13 hours; garbage pickup 4.5 hours; gravel hauling – 46 hours; total tons hauled – 281.55 1" rock hauled into yard; sign repair – 16 hours; weed work – 8 hours; several grading and snow removal concerns. Working on NIRMA Grant for Vests and grant for I Adams bridge.

Board discussed whether to place stop signs at intersections of Hank's Way/Rottunda Way and Cardinal Way/Rottunda Way or not. The engineer study opinion was they were not recommended. Some residents from that area that the Board had visited were not in opinion they were needed. Commissioner Van Berkum moved, seconded by Commissioner Bousquet to not install stop signs at intersections of Hank's Way/Rottunda Way and Cardinal Way/Rottunda Way and leave as is. ROLL CALL VOTE: Hohenstein-Yes; Rodriguez-Yes, Van Berkum-Yes, Bousquet-Yes, Reed-Yes. UNANIMOUS MOTION CARRIED.

Commissioner Bousquet moved, seconded by Commissioner Van Berkum to approve the snow removal contracts for 2026 with Steve Harris Construction Inc., Oban Construction, and Midwest Constructors if the County Road Department needs help due to significant snow accumulations. ROLL CALL VOTE: Rodriguez-Yes, Van Berkum-Yes, Bousquet-Yes, Reed-Yes, Hohenstein-Yes. UNANIMOUS MOTION CARRIED.

Commissioner Committee Reports: None.

Mail and/or Emergency Business: Reminder the December 22, 2025 meeting will begin at 9:00 a.m. NIRMA sent a Property Audit Report booklet that is available for all to view in the Clerk's office. Commissioner Reed received an email from FHP requesting the Board to authorize the County Assessor to share GIS Shape files with them for free. The County Assessor believes they should have to pay like any other vendor. This item will be on the next agenda.

Commissioner Van Berkum moved to adjourn. All in favor. Chair Hohenstein adjourned the Board of Commissioners meeting of December 8, 2025, at 3:50 p.m.
